Jane's Due Process is the only organization ensuring legal representation for pregnant minors in the state of Texas. Over the last 15 years, Jane's Due Process has helped thousands of our most vulnerable Texans make safe and informed choices about how and when to become a parent.

#### What we do

#### 24/7 Legal Hotline

Jane's Due Process' 24/7 legal hotline is a free, confidential resource for teens facing unplanned pregnancies. Young women turn to us when they need accurate and reliable information about their legal rights from a source they know they can trust.



Our hotline offers information on the following topics:

Emancipation - Title IX & Education Access
Confidential Family Planning - Judicial Bypass
Teen Dating & Family Violence - Protective Orders
Adoption, Parenting & Abortion

#### **Attorney Referral Program**

A judicial bypass is a legal alternative if a teen is unable to locate or safely obtain consent from a parent or legal guardian to have an abortion. After a minor has received pregnancy counseling from a trusted clinic and decides she wants to seek a judicial bypass, Jane's Due Process refers her to an experienced attorney among our statewide network. The attorney guides the teen through the legal obstable course with respect, compassion, and expertise.

# **News** From the Legislature & Courts

#### **Effects of HB2**

Since HB 2, the sweeping omnibus legislation that closed the majority of abortion clinics throughout Texas, and the dismantling of the family planning providers, young women are caught in the middle, often unable to obtain either contraception *or* abortion services.

Challenges to HB 2 are making their way through the courts. As of early April, the U.S. 5th Circuit Court of Appeals is reviewing the merits of the case challenging the law after the Supreme Court upheld an injunction against one of the requirements and allowed clinics in McAllen and El Paso to remain open. Even if the 5th Circuit were to rule in favor of the clinics, the few remaining clinics are in the urban centers, leaving rural teens without access to services.

80% of our clients are referred through abortion providers; with fewer and fewer clinics, we fear that many minors don't know they can count on us.

## 84th Legislature

After regulating the clinics out of existence last session, this year's legislative spotlight is on abused and neglected teens seeking a judicial bypass. The current law provides a rare yet critical safety net for a few hundred teens each year. These teens do not have a stable adult in their life, yet lawmakes are attempting to make judicial bypass practically inaccessible.

Lawmakers have introduced six bills that would either dismantle or amend the judicial bypass process, which is required by U.S. constitutional law.

The bills would have the following impact:

- Risk the anonymity and confidentiality of minors
- Jeopardize the safety of minors by second guessing their assessment of threats or abuse in their homes
- Publicly identify judges ruling on judicial bypass cases, putting judges and courthouse staff in danger
- Drastically lessen the expediency of the process, forcing teens to continue unwanted pregnancies while they navigate additional logistical challenges
- Place a greater burden on CPS workers, a system that is already strained

# Who is Jane?

In 2014, Jane's Due Process fielded close to 1,000 calls from Texan teens seeking information about their legal rights and pregnancy options. Of those callers, 281 young women from 55 different counties needed legal assistance with a judicial bypass.


Our 2014 judicial bypass clients, at a glance:

39% did not live with a parent or legal guardian. Most of their parents were deceased, missing, incarcerated, deported, or living abroad

16% had been pregnant before

11% were already parenting one or more children

# **Judicial Bypass Outcomes**

Minor referred to JDP network attorney program	143
Minor referred to court appointed attorney	34
Minor referred to explore pregnancy options- outcome unknown	78
Minor indicated intent to seek consent from parent	5
Minor indicated intent to seek consent outside of state	8
Minor indicated intent to seek abortion after 18th birthday	6
Minor indicated intent to continue pregnancy after discussing abortion option through hotline screening	5
Minor had miscarriage before participating in judicial bypass process	2

The most common reasons that Janes did not use birth control at the time they became pregnant were: lack of parental consent, cost and transportation, and misunderstading the effectiveness of condoms.

"I first visited a crisis pregnancy center and they scared me so bad that I put off calling. My parents will kick me out if they find out I am pregnant. I am really scared to tell them because I will have no place to live."

# We've Got Work to Do!

## **District Clerk Report**

"Both of my parents are in prison and my aunt is emotionally abusive. I do not have anyone to ask to sign the medical consent form."

Every few years, we conduct a survey to ensure that district clerks are in compliance with the law requiring them to provide accurate information and paperwork to any minor calling to apply for judicial bypass. This year, our results were overwhelmingly disappointing and highly concerning. Teens calling district courts directly are facing an onslaught of misinformation and unfiltered indifference.

#### Here are our findings:

- 26% of counties provided entirely accurate information
- 81% of counties had no immediate knowledge of the existence of judicial bypass
- 37% of counties denied their office's involvement in judicial bypass
- Certain clerks gave unsolicited religious advice and judgment, referred the caller to crisis pregnancy centers, or even just hung up the phone

# These findings remind us why our services are so vital for pregnant teens in Texas.

We will continue working to ensure that every teen understands and can exersice her legal rights. As our work grows more challenging, so too it becomes more important. Thank you for supporting the only organization ensuring the legal rights of pregnant teens in Texas.
