In the fall of 2017, a pregnant 17-year-old was held by the federal government at a Brownsville detention center for teens who cross our border alone and without documentation. This young woman-Jane Doewas one of our clients.

Having escaped an abusive household in a Central American country, Jane Doe made a treacherous journey to Texas. But instead of being reunited with family members, she was detained. When she discovered she was pregnant, she asked for medical attention to terminate her pregnancy. We helped Jane get a judge's permission to bypass the state's requirement for parental consent. However, the federal government ignored the state judge's order and refused to allow Jane to go to her abortion appointment, ultimately delaying her care for more than a month.

With the help of the national ACLU, Jane's case went all the way to the DC Court of Appeals which ruled that the government agency, Office of Refugee Resettlement and its director, Scott Lloyd, could not hold her hostage.

Since then, more immigrant Janes have sought legal relief in courts across the country.

In Texas, many young women face the same plight—their right to make their own choice is threatened and often denied. Jane's Due Process is here to help, to advocate, to educate, and to support. Just like we fight for all "Janes," we kept fighting for Jane Doe, and she finally received the abortion care she needed.




WHO IS JANE?

SOCIAL MEDIA & OUTREACH


Responding to feedback from teens, we launched a confidential text hotline in 2017. Our hotline has gotten 242 texts with questions about pregnancy and birth control, judicial bypass, and abortion.

In our interactions with teens seeking judicial bypass, we realized that most young people in Texas aren't aware of their reproductive rights. In 2017, we doubled down on public education, using paid advertising on social media platforms and outreach at events and conferences. On Instagram, we reached over 150,000 young women between the ages of 14 and 17, sharing information about access to free, confidential birth control at Title X clinics and the right to judicial bypass.

In one December day on Snapchat, over 1,000 people at malls across the state saw our sponsored geofilters which told them how far away they were from their nearest Title X clinics. These clinics offer free birth control to minors without parental consent, and also provide pregnancy options counseling and STI testing and treatment.

Thanks to our talented volunteers, we were able to produce two videos in 2017 that brought alive the stories of two Jane Does.



We shared a Jane Doe's moving story in the animated video "Story from Jane: Kind, Respectful, Caring." The story is told in Jane's own words - find it on our facebook page & our blog!
