ABOUT JANE'S DUE PROCESS

Jane's Due Process ensures legal representation for Texas minors who want to exercise their reproductive rights. Since our founding in 2001, JDP has supported teens seeking judicial bypass to obtain abortion, developed programming to help teens access birth control, supported organizations in other states learning more about how to support teens' reproductive rights, and provided information to thousands of Texas teens about their reproductive and sexual health decision making.

WHY DOES JANE NEED A JUDICIAL BYPASS?

Jane can choose more than one reason.

41% parents will not consent

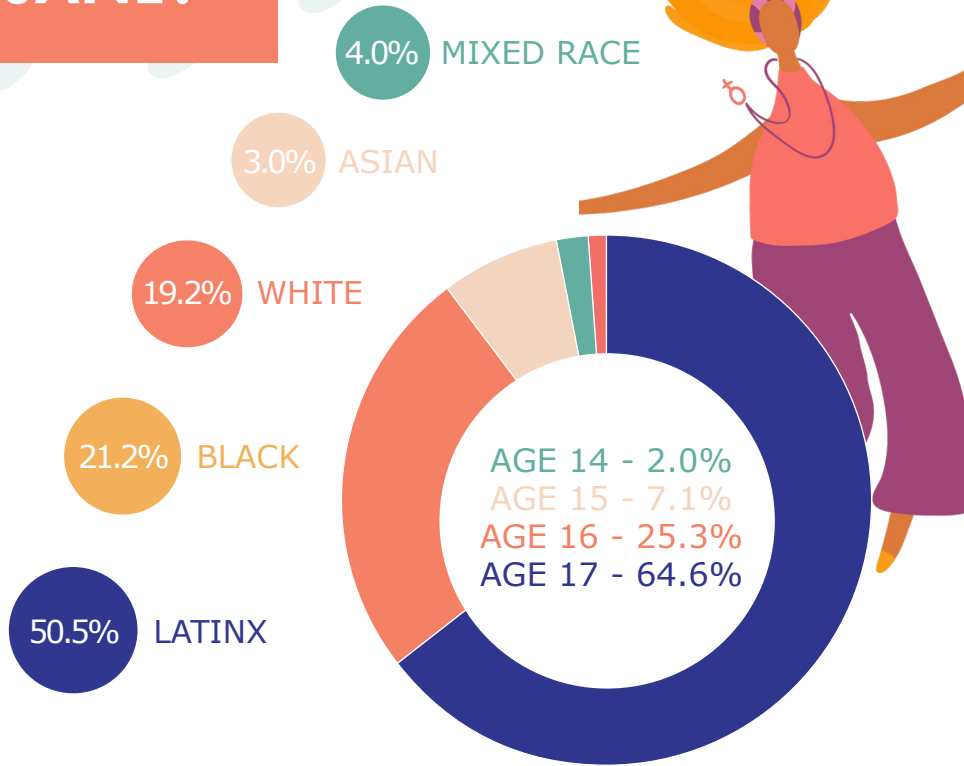
37% fear physical, emotional, or sexual abuse

28% parents will kick out minor

22% are not living with a parent or guardian

7% parents are unable to go to clinic

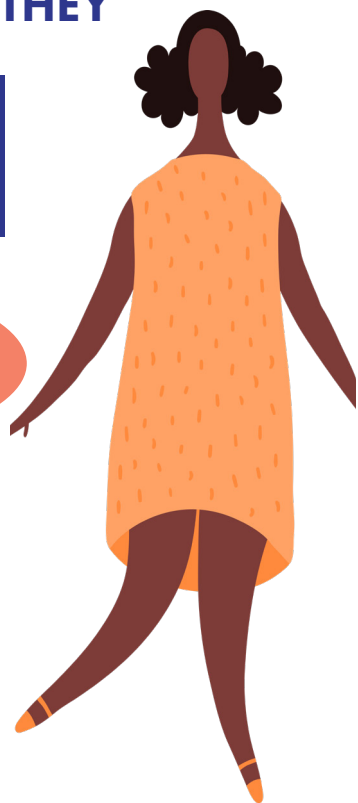

IN 2018, JANE'S DUE PROCESS...

Co-hosted 123 participants at the first national conference for organizations working to support teens' reproductive rights and access.

Hired a Community Outreach and Youth Engagement Coordinator

Participated in the Youth Testify program of the National Network of Abortion Funds and Advocates for Youth. Four of our clients were recruited to share their abortion stories.

Developed a peer-to-peer program providing emotional support to Janes in the process of judicial bypass.

Worked with researchers on a report in the Journal of Adolescent Health.

Improved outreach to teens using social media ads telling them where their nearest Title X clinic was.

Jane's Due Process is a small organization working to reach teens across Texas. Because we support abortion access, we are unable to receive government funding, and rely completely on our individual supporters and private foundations.

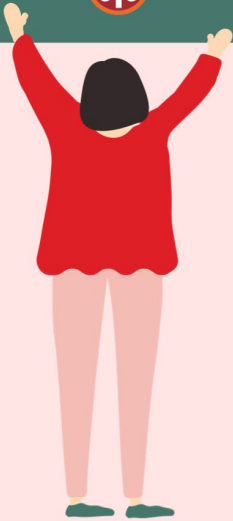
